**COUNCIL OF IROIJ (COMPENSATION AND EXPENSES)  
(AMENDMENT) ACT, 2018**

**AN ACT** to amend Section 202 of the *Council of Iroij (Compensation and Expenses) Act 1979* to adjust the compensation of members of the Council of Iroij.

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short Title**

This Act may be cited as the Council of Iroij (Compensation and Expenses) (Amendment) Act 2018.

**§102. Amendment.**

1) Section 202 shall be amended by revising the existing language as follows:

**§202. Council of Iroij; compensation.**

(1) Members and officers of the Council of Iroij shall receive as compensation an annual salary, payable in bi-weekly installments as follows;

(a)	Chairman	\$31,250
(b)	Vice Chairman	\$25,000
(c)	All other members	\$18,750

**§103. Effective Date.**

This Act shall take effect in accordance with the Constitution and the Rules of Procedures for the Nitijela provided, however, that nothing in this Act shall take effect until Fiscal Year 2019.
