This matter came before the Court for a pre-trial conference on June 29, 2018. Plaintiff was not present but was represented by counsel Divine Waiti. Defendants were not present but were represented by counsel James McCaffrey. Counsel and the Court discussed the status of the case and the pending motions.

BASED ON THE FOREGOING, IT IS HEREBY ORDERED AS FOLLOWS:

1. Defendant's motion to enlarge time to file pre-trial motions is granted. Any party may file additional pre-trial motions on or before July 23.
2. Plaintiff's June 25 motion for summary judgment is accepted.
3. Responses to all pre-trial motions now pending or filed on or before July 23 shall be filed on or before August 13.
4. Replies, if any, shall be filed on or before August 20.

5. Discovery is closed. No party may initiate additional discovery.

6. Oral arguments on all pre-trial motions now pending or filed on or before July 23 will be heard at 2:00 p.m. on September 4. A final pre-trial conference will also be held at that time.

7. Before the final pre-trial conference, each counsel shall provide to the Court and opposing counsel:

- (a) the name of each witness to be called in his client's case-in-chief;
- (b) a brief summary of each such witness's expected testimony;
- (c) contact information for each such witness;
- (d) a legible copy of each document intended to be introduced in his client's case-in-chief, pre-marked with a numbered exhibit sticker; and
- (e) a list of each such document that contains the exhibit number and title of each such document.

Failure to timely and fully comply with this paragraph may result in the exclusion of omitted witnesses' testimony and the exclusion of omitted documents at trial.

8. The bench trial scheduled for October 10-11, beginning at 9:00 a.m. each day, remains as previously scheduled.


