INTRODUCTION

On June 26, 2018, plaintiff filed a motion for summary judgment. The motion was untimely. However, permission to file the motion was granted during a pre-trial conference held June 29, and the motion was deemed filed on that day. On August 13, defendants filed an opposition to the motion. Plaintiff did not file a reply. Oral arguments were held on September 4. Plaintiff was not present but was represented by counsel Divine Waiti. Defendant Leander Leander was present and was represented by counsel James McCaffrey. Defendant Lijun Leander was not present but was represented by counsel James McCaffrey.

STANDARD

Summary judgment is appropriate when the moving party shows there is no genuine issue as to any material fact and that the moving party is entitled to judgment as a matter of law.

ANALYSIS

As discussed and noted during the oral arguments, there are several genuinely disputed facts. Summary judgment is therefore inappropriate.

ORDER

Plaintiff's motion for summary judgment is denied.




