





**Counsel:**

As I promised during the hearing on September 4, I reviewed the court file to determine if the nuisance (alleged prostitution) issue has been sufficiently raised in the pleadings to justify allowing evidence of it to be introduced in the trial of 2014-067. I will notify you of that decision in an "Order in Limine" that I plan to release later today.

The purpose of this e-mail is to alert you to something I discovered during my review of the 2014-067 court file that appears to have significant impact for all of the pending Eigigu cases. The issue is this: Was Ruben Tsitsi the agent of EHC?

On November 10, 2014, John Masek filed an affidavit in Case No. 2014-067. He was, at the time, representing the Leanders. The affidavit includes references to another High Court Civil Action, No. 2013-005.

I examined the court file for 2013-005. It contains several pleadings, affidavits and exhibits that address the relationship between Tsitsi and EHC. If those documents are admitted during the upcoming Eigigu trials, either through the testimony of witnesses or via judicial notice, they will likely carry significant weight on the issue of Tsitsi's agency or lack of agency.

I am not pre-judging the agency issue. I make this disclosure because each of you would be wise to examine the 2013-005 court file as you prepare for your trials or negotiate settlements. I will say nothing more.
