

On September 6, I granted plaintiff the opportunity to file a motion to amend its complaint. Plaintiff filed the motion on September 21. Defendants filed a response in opposition on September 27. I have reviewed the motion and the response, and I have spoken with counsel about the motion in an unrecorded in-chambers conference on October 4.¹

BASED ON THE FOREGOING, IT IS HEREBY ORDERED AS FOLLOWS:

1. On or before October 10, plaintiff shall file an amended complaint that merges the newly proposed allegations and newly proposed requests for relief into the original complaint that was filed on April 7, 2014. Plaintiff shall not change any of the provisions of the original complaint; plaintiff shall only add the newly proposed allegations and requests for relief.

2. Defendants need not file an answer or other responsive pleading to the amended complaint.
