The parties have previously filed Joint Motions to Enlarge Time and Set a Briefing Schedule (16 January 2019) and Enlarge Brief Page Limits (5 March 2019). The Supreme Court has granted both motions.

Plaintiffs-Appellants Reply Brief is currently due on 27 May 2019, twelve calendar days after the filing of Defendants-Appellees Answering Brief on 15 May.
