

2. The presumed bail for any Attempt pursuant to 31 MIRC 1 § 105 will be ½ the presumed bail for the underlying offense.
3. Transients, short-time residents who have no job or real ties with the Marshall Islands, and previously convicted felons are required to put up twice the amount of cash bail as indicated and will normally be required to surrender their passport to the court.
4. The amounts listed are presumptive amounts and may be raised or lowered by a magistrate at his or her discretion. These presumptive amounts may and shall be used by police and jail officials if and when a magistrate cannot be located.
