**ENFORCEMENT OF JUDGMENTS (AMENDMENT) ACT,  
2020**

**A Bill FOR AN ACT** to amend Section 102 of the Enforcement of Judgments Act, 30 MIRC Chap. 1, to lower the statutory interest on money judgments from 9% per annum to 6% per annum.

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short title.**

This Act may be cited as the Enforcement of Judgments (Amendment) Act, 2020.

**§102. Amendment.**

Section 102 of the Enforcement of Judgment Act, 30 MIRC Chp. 1, is amended to read as follows:

**§102. Money judgments.**

A judgment for the payment of money shall be a lien upon the personal property of the judgment debtor and shall bear interest at the rate of six percent (6%) a year from the date it is filed. The process to enforce a judgment for the payment of the money may be a writ of execution or an order in aid of judgment, as provided in Part II of this Chapter.

**§103. Effective Date.**

This Act shall take effect on the date of certification in accordance with Article IV, Section 21 of the Constitution.


