

# JUDICIAL COMPENSATION (AMENDMENT) ACT 2021.

**A BILL FOR AN ACT** to amend Section 402 (1) of the Judicial Compensation Act 1983, 27 MIRC Ch. 4, to increase the annual salaries for the judges of the Traditional Rights Court by \$5,000, consistent with the importance of customary law and traditional practices in the Marshall Islands.

#### BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS

## §101. Short title.

This Act may be cited as the Judicial Compensation (Amendment) Act 2021.

## §102. Amendment.

Section 402(1) of the Judicial Compensation Act 1983 is amended to read as follows:

(1) The annual salaries of judges, other than judges of the Community Courts, are as follows:

Chief Justice of the Supreme Court	
Associate Judge of the Supreme Court	\$25,000
Chief Justice of the High Court	
Associate Justice of the High Court	\$80,000
Presiding Judge of the District Court	
Associate Judge of the District Court	\$30,000
Chief Judge of the Traditional Rights Court	

Associate Judge of the Traditional Rights Court

\$35,000

## §103. Effective Date.

This Act shall take effect on the date of certification in accordance with Article IV, Section 21 of the Constitution.
