**JUDICIAL COMPENSATION (AMENDMENT) ACT 2022.**

AN ACT to amend §402 (1) of the Judicial Compensation Act 1983, 27 MIRC Ch. 4, to provide a salary range for the judges of the District Court, which would allow step increases based upon the length of tenure and merit totalling up to \$5,000.

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short title.**

This Act may be cited as the Judicial Compensation (Amendment) Act 2022.

**§102. Amendment**

§402(1) of the Judicial Compensation Act 1983 is amended to read as follows:

Chief Justice of the Supreme Court	\$30,000
Associate Justice of the Supreme Court	\$25,000
Chief Justice of the High Court	\$90,000
Associate Justice of the High Court	\$80,000
Presiding Judge of the District Court	\$38,000
Associate Judge of the District Court	\$35,000
Chief Judge of the Traditional Rights Court	\$38,000
Associate Judge of the Traditional Rights Court	\$35,000

**§103. Effective Date**

This Act shall take effect on October 1, 2023, in accordance with Article IV, Section 21 of the Constitution.
