Fred ej ba bwe ewor an maron ilo jikin eo ilo Kineloke im Leroij Kalora Zion im, kar Alap im Senior Dri Jerbal, Lejka Mack, rekar ajelok nan e ilo 1989 eo.

Rijumae Abnono Winton Maun (“Winton”) ear wonmanlok wot im kalok juon an imon jokwe bedbed ioon melim eo lelok nan e jen ro tellokier im rej maron ilo Kineloke ilo torre eo, Iroijedrik Jeltan Lanki, im Alap im Senior Dri Jerbal Tarmute Motlok, ilo 2006.

Leroij Kalora Zion ear jab loe notaan kajitok eo an Lejka Mack ikiken an ajelok maron eo an [Senior] Dri-Jerbal nan Fred, im ear wonmanlok wot im lelok melim eo an. Kemij loe bwe ilo case eo an *Kelet, et al., v. Lanki and Bien*, 3 MILR 76, 82, at 77 (2008), Supreme Court eo ear ba bwe jemlok eo an Court eo an Manit ke Namidrik, eo im ear bed maron ko jimor an Alap im [Senior] Dri Jerbal, “...ear jimwe an ajelok maron ko jimor an alap im [senior] dri jerbal nan kora eo riturin,” Limoj, ejimwe im ekkar ilo an kar wor melim jen ibben iroij eo ekkar, Iroij[edrik] eo. Limoj, eo im ejjab itok jen bwij eo, ear tokelik ajelok maron eo an Senior Dri Jerbal nan kora eo jeran, Libarki, eo im ejjab bareinwot mottan bwij eo. Leroij Kalora Zion, einwot Iroijedrik eo ilo tore eo, ear droor eltan pein nan komelim an Alap im [Senior] Dri Jerbal Lejka Mack ajelok maron eo an [Senior] Dri-jerbal nan Fred.

**C. Ewor ke an Rijumae Abnono Winton Maun maron ioon bwidej eo ilo case in?
Im emaron ke kalok juon an imon jokwe ie?**

Ewor an Rijumae Abnono Winton Maun, eo im emoj an jako ilo kilan mej, maron ilo Kineloke Rak Weto einwot juon nejin bwij eo. Kin menin, Rijumae Abnono Winton emaron in kalok juon an imon jokwe ilo Kineloke kin melim eo jen ibben Iroijedrik, Alap im Senior Dri Jerbal ro aer Kineloke Rak Weto. *Section 1(2) in Article X eo ilo Jemen-Ei eo.*
