Case in ar itok non Traditional Rights Court eo non etale ekkar non manit, abonono eo ikotan brothers rein ruo, defendant Joria Jennat, im defendant Tior Jennat. Case in ej kin wot title eo an alab ilo Monkono Weto im brothers rein jimor rej claimi jen dron. Court in an manit ej kile bwe juon in case elab an emon im jemaron bok ad katak jene. Kin menin, Court in ej kile ke manit elab an aurok im lab ijo kunan non bukot mejlan abonono in ikotan brothers rein bedbed wot iumin manit. Ro uwan Panel eo ar Honorable Associate Judge Botlang Loeak, Honorable Associatge Judge Kalemén Jinuna, im Honorable Berson Joseph, Chief Judge eo an Traditional Rights Court eo.

agreement in ar emon im “karbob” mantak wot mae October 28, 2004.

Ilo October 28, 2004, Defendant Joria Jennat ar je juon an letter non Bank of Marshall, the Plaintiff, bwe ien eo emokaj tata Bank in en kolla onen lease eo none kin drettan jonon in \$1,491.00 ilo juon year. Jouij im lale kain kamol an riabonono B. Ak ilo kar February in 2004 eo, Bank of Marshall, riabonono ar loe juon “directive” jen Leroij Atama Zedkaia bwe ej kile TiorJennat bwe e eo ej alab in Monkono Weto im ekkar bwe en bok kolla ko jen Bank of Marshall. Jouij im lale kain kamol an riabonono C.

Bank of Marshall, ri abonono eo ilo case in, kio ebed ikotan ruo “mowi” im ejjab jela won eo eaijuj deal ibben kin payments in lease agreement eo an Monkono Weto. Kin menin, ear filed case in an im jakemantak non court bwe en etale im kwalok jejjet im jimwe eo bwe lease payments ko an Monkono Weto ren ilok none. Mr. Tior Jennat, kwon jolok am bwid ibben likao ne jeium, bwe brotherly love emon im aurok




